January 30, 2023

The Regular Meeting of the Wilson County Appraisal District Board of Directors was held on Monday, January 30, 2023 at the Appraisal District office located at 1611 Railroad Street, Floresville, Texas. She explained that the Appraisal Districts portion of the server is \$38,031.75 and the Tax Offices portion is \$13,491.60 for a total of \$51,523.35.
